- Till the deficiency in reservation for representation of scheduled caste, scheduled tribe and other backward categories is balanced, future vacancies shall be reserved for concerned reserved candidates in all the posts.
- Only after confirmation of authenticity of all marks sheet/ certificates with regard to educational qualifications of all the teaching/ non-teaching staff of this college by the concerned authority, action shall be initiated for payment of salaries.
- If appointed under scheduled caste/ scheduled tribe and backward categories, only after obtaining validity certificates with regard to their caste form the concerned authority, action shall be initiated for payment of salaries to such employees.
- 4. If any employee holding approved post is found to have furnished false statement/ incorrect information, appointment of such employee would be cancelled.
- The salary grants of these employees shall come into force from the date of this order. For any reasons, their previous service shall not be considered for salary grants.
- 6. Results of the said college shall not be below the results of other colleges recognized by the University. In this regard, action shall be initiated on confirmation of eligibility acquired to include under salary grants on the basis of results for previous 5 years in this regard.
- Adjustments shall be made to meet the expenditure incurred in including the said college to salary grants, with the planned grants limits provided to the Department.

8. As per NCTE-2009 regulations, the Principal shall possess prescribed educational qualification within two years from the date of issuance of this
